Atlantic Shower Door will warranty the ClearShield Glass Treatment for 10 Years with proper cleaning and care. If you are not 100% happy with the ClearShield glass treatment, we will come out and reapply the ClearShield at no charge.

CLEARSHIELD® LIMITED LIFETIME WARRANTY

For Residential Shower Enclosures

Clean Glass Solutions, LLC (CST) warrants to the original end customer, that ClearShield® treated shower glass will remain easier to clean and keep clean compared with untreated shower glass and will remain resistant to glass surface corrosion, staining, and discoloration for the life of the shower glass. Clean Glass Solutions, LLC also warrants that for the lifetime of the shower glass that ClearShield® protection will not crack, peel, or flake. This Limited Lifetime Warranty applies only to new shower glass where ClearShield® has been applied by an authorized ClearShield® applicator. This Limited Lifetime Warranty applies only to the original end customer who resides within the property at which the glass with ClearShield has been applied and is not transferable. Determination of the validity of claims related to this Limited Lifetime Warranty shall be made in the sole judgement of Clean Glass Solutions, LLC. This Limited Lifetime Warranty does not cover and expressly excludes scratches, stains, pitting, discoloration, deterioration, contamination, or damage from (i) abuse, neglect, misuse, or accident. (ii) improper care, use of abrasive cleaning compounds, pads or methods, or high alkaline or acidic cleaners (iii) Exposure to abnormal or extreme conditions. Excludes showers in rentals, commercial properties, and short term rental units (Airbnb, etc). Please contact Clean Glass Solutions for warranty information on these types of properties. To obtain coverage under this Limited Lifetime Warranty, the original end user customer must:

- I. Register the purchase online at www.clearshieldonline.com/warranty-registration-after-care within 60 days of installation;
- II. Maintain the ClearShield® protected shower glass per “Recommended After-Care Program for ClearShield® protected Shower Glass” available on www.clearshieldonline.com , also emailed to end user when they register their warranty, and available from your shower glass installer

Warranty Claim Procedure (in order of escalation):

- I. CGS may request information on the issue including pictures of issue in order to resolve claim
- II. CGS will provide the end user a Warranty Claim Kit with products to resolve issue, or other products deemed necessary to resolve issue
- III. At Clean Glass Solutions discretion they may either:
 - a. Send a representative on-site to review and resolve issue
 - b. Reimburse the end user for the cost of the ClearShield® protection only, not to exceed \$6 USD per square foot of protected side of glass. Customer is responsible for providing CGS with invoice with clear documentation that ClearShield® was installed on glass including the price for ClearShield® protection to receive this benefit. Do not depend on installer to provide copies of invoice post installation.
